HAZARDS & LIMITS



All protective equipment has limits. Injuries might occur, even when wearing shin guards. Shin guards protect bones, soft tissue and skin from kicking, collisions, laceration, other blows and violent impacts. However, it is impossible to completely cancel the possibility of injury in the form of fracture, contusion, sprain, laceration etc.

Each accident is unique and many variables impact the risk of injury (refer to our website for more information). Nevertheless, studies have repeatedly shown the benefits of wearing shin guards. Only the covered areas have a reduced injury risk. No shin guard can protect against toe, foot, or knee injuries.

Batoco's shin guards SGP1 offer limb protection in accordance with standard EN 13061:2009.

The shin guards offer protection during the regular practice of associative football or soccer. The shin guards are not intended for other sports such as American football, rugby, ice hockey, field hockey etc.



PROTECTED AREA

All Batoco shin guard models are designed to reduce the risk of injury to the lower leg associated with the practice of football.


The protected zone depends on the shin guard model: Ankles can be included in the protection area (1) or not (2). SGP1 model does not have ankle protections (2).




SIZING, FIT & USAGE DIRECTION

Batoco shin guards are unisize. Their shape and built suit most leg morphologies. SGP1 model is suitable for a user's height of 140-170cm.

To fit your shin guards, position them directly against your legs as low as you can. Make sure to wear your football shoes and socks. Cover your shin guards fully with your socks. Walk around as you would when trialling shoes. Perform 90 and 180 degree turns, verifying that the shin guards do no hinder or restrain movement.



If the shin guards are loose (4), do not conform to your legs (5) or restrain movement (6), try out a different model. Note that choosing another model with a smaller protective surface results in less protection. The padding colour does not influence the protective capabilities of the shin guards.



Shin guard models with an ergonomic left and right shape are marked with a L and R respectively. Not all models have a special ergonomic shape. SGP1 model for instance does not have an ergonomic shape.



USAGE DIRECTIONS

After approving your model:

1. Place the shin guards soft part against the front of your legs as low as possible. The foam should not slide along your legs. Verify the left and right side if your model is not interchangeable. SGP1 is interchangeable.
2. Secure the positioning of the guards with the use of supports, elastic bandages or adhesive tapes if the shin guards are not fully stable and covered by your socks.

STORAGE AND MAINTENANCE

Batoco shin guards need to be stored in a dry and ventilated environment to facilitate sweat elimination on the foam surface and prevent the formation of unpleasant odours. The foam does not take up humidity.

Keep the shin guards away from heat sources and long-lasting sun exposure. These can damage the foam and the finishing of your guards.

Hand cleaning of the outer shell depends on the finishing package chosen. In case of a vinyl finish, a watered microfiber cloth should be wiped on the surface, then dried. Ensure no presence of solid materials in the cloth that could scratch the surface. Painted shells can be cleaned with any high-quality product used for the care of automotive finishes. The foam should only be cleaned with mild soap and water on a cloth.

PRECAUTIONS



Do not use solvent-based products to clean the foam as this could result in damage and loss of protective properties.



Paint can react with the foam and therefore reduce the protective capabilities of your shin guards. Batoco recommends caution if shin guards are redecorated by yourself or independent painters.



Batoco shin guards should not be washed unless specially mentioned for your model.



Washing



Bleaching



Drying



Ironing



Dry Cleaning



Do not attempt to modify the shin guards in any way: cutting a part of the protection zone, changing the foam, bending and folding the shell, etc.



Any degradation on the shin guards requires their immediate replacement. Cracked shell, broken shell, loose foam, broken foam, swelled parts, veining, tears etc. are all degradation signs.



Shin guards are constructed to help absorb the force of a hit. Damage such as fractured shell or pierced foam caused by an impact is not a sign of a manufacture defect. The behaviour is exactly how Batoco shin guards protect against injuries.



Any changes in environmental conditions may reduce the performance of the shin guard model chosen.



With use (repeated blows, friction during playing, washing etc) the protection might decrease. Foam might also deteriorate over time (>5 years). A guard's manufacturing date can be traced through its serial number. Batoco recommends replacing your guards every 5 years to take advantage of advances in protective capabilities.

INSPECTION SERVICE

Your carbon shin guards at least require close inspection after an important impact. On the outside, you should look for signs of delamination or surface cracking and exposed composite material under the vinyl or paint finishing. On the inside, you should look for damaged foam. Nevertheless, even the most thorough inspection can fail to detect signs of damage. Replacing your shin guard pair once it has been subject to a significant impact is therefore best practice.

If your shin guards have less than five (5) years, Batoco will examine your shin guards free of charge and estimate the repair cost of your protective equipment to a like new condition. Repairs will only be performed with your approval and only if the shin guards can be returned to their original condition. All returns are subject to a Batoco approved RMA and Batoco reserves the right to refuse to repair shin guards which have been altered by the owner or any third party.

LIMITED WARRANTY

Any Batoco product determined to be defective, in material or craftsmanship, by a Batoco quality control within two (2) years from the date of retail purchase will be repaired or replaced at Batoco's option. The repair or replacement is free of charge when received at Batoco freight prepaid, together with the proof of purchase and the RMA.

This warranty is expressly in lieu of all other warranties. Any implied warranties of merchantability or fitness for a particular purpose are limited to the same duration as this express warranty. Batoco shall not be liable for any incidental or consequential damages. Some countries / states do not allow the exclusion or limitation of implied warranties, incidental or consequential damages, so the above limitations and exclusions may not apply to you.

This warranty does not cover damage resulting from misuse, abuse, neglect, alteration, failure to perform maintenance as instructed or unauthorized repair or service. This warranty does not cover any representation or warranty made by dealers beyond the provisions of this warranty. You must establish proof of purchase to obtain warranty service or replacement. This warranty gives you specific legal rights, and you also have other rights, which vary from country to country or state to state.

Shell: 90% carbon composites, 10% fiberglass composites.

Padding: 100% polyethylene.
